

TERMS AND CONDITIONS OF THE STIMULATING LOTTERY WITH DRAW "SHOPPING WITH VISA AT PARK BULVAR FROM YOU, CARS AND GIFTS FROM US!"

Participants are deemed to have accepted these conditions by participating in the Stimulating Lottery with draw, which constitute a legal obligation between the Lottery Organizer and the Participant. Participant may not assign or otherwise transfer (in whole or in part) your rights and/or obligations under these Terms except as permitted hereunder.

Title and type of the lottery: STIMULATING LOTTERY WITH DRAW, NAMELY "SHOPPING WITH VISA AT PARK BULVAR FROM YOU, CARS AND GIFTS FROM US!"

**IMPORTANT: PLEASE READ THESE TERMS CAREFULLY
TERMS:**

1. The stimulating Lottery with draw will be held from **25th November 2024 to 28th March 2025** at the all sales stores of PARK BULVAR located in the territory of the Republic of Azerbaijan by purchasing with a VISA card.
 - 1.1. The objects of the lottery: Goods and services purchased with a VISA card are available in stores and facilities located in the Park Bulvar Trade Center that participated in the lottery. Cash payments and other card purchases are not object of this lottery.
- NOTE: Alcoholic beverages, tobacco and tobacco products are not allowed to participate in the lottery as lottery objects. Thus, when the Participant makes a purchase with a VISA card at PARK BULVAR, the receipt for every purchase worth with a total minimum purchase requirement of 50 (fifty) manats should not contain alcoholic beverages, tobacco and tobacco products, otherwise that receipt cannot participate in the Lottery. A person who does not fulfill the requirements of this clause is not accepted as a lottery participant.
- 1.2. In order to participate in the lottery, participants can use cashless VISA card cards registered in the Republic of Azerbaijan and issued by any bank from all sales points of PARK BULVAR located in the territory of the Republic of Azerbaijan from November 25, 2024 to March 28, 2025, as well as any installment (partly), mobile, NFC, QR code payments and must make purchases at one or more points of sale with a total minimum purchase requirement of 50 (fifty) manats for each purchase, including through any POS terminal. When the payment is made by VISA card card, check(s) of the control cash register will be presented for the purchase made by the points of sale located on PARK BULVAR. In order to participate in the lottery, the Participant must bring the check(s) to the Information Center (hereinafter referred to as the "Information Center") located at PARK BULVAR from 10:00 a.m. to 10:00 p.m. specified in Clause 1.5 and register the check(s). The Information Center verifies that the check(s) submitted conforms to the terms of this Lottery and affixes the "Approved" stamp (a sample of the stamp is attached) on the back of the check(s) submitted. The Information Center provides the Participant with certified stamped check(s) sewn to one part of the special two-part lottery ticket (a copy of the lottery ticket is attached) and the other part of the lottery ticket is separated and sent to the lottotron (one lottotron with dimensions of 100x50x50 is provided for each draw) thrown away. Thus, the Participant will have to join the lottery.
 - 1.3. During the 1st draw of the Lottery, the Participant must register during the 1st draw period in accordance with the procedure specified in clause 1.2 of these terms and conditions in order to be eligible to participate in the drawing of the prize fund for the 1st draw. In case of non-registration, the participant is released from the right to participate in the lottery. If the Participant obtains the relevant check(s) during the 1st draw, but the check(s) is registered during the 2nd draw in accordance with the procedure specified in clause 1.2 of these terms, then the Participant will receive the winning fund for the 2nd draw. A person who does not fulfill the requirements of this clause is not accepted as a lottery participant.
 - 1.4. **All new lottery tickets registered during the 2nd draw of the Lottery, as well as the participants who won and participated in the 1st draw of the Lottery have the right to participate in the Lottery for the 2nd draw by obtaining new lottery tickets in accordance with the procedure specified in clause 1.2 of these terms and conditions.**
 - 1.5. The Participants who want to participate in the lottery must include the following information during registration:
 - 1.5.1. Lottery Participant's name, surname, father's name and date of birth;
 - 1.5.2. Lottery Participant's mobile number, e-mail address;
 - 1.5.3. The date indicated on the check(s) received by the Lottery Participant;
 - 1.5.4. The total amount stated on the check(s) received by the Lottery Participant;
 - 1.5.5. The name of the sale store mentioned on the check(s) purchased by the Lottery Participant.
 - 1.6. The Participant who joins the lottery shall accept all terms and conditions.

- 1.7. A check(s) with a total value of at least 50 (fifty) AZN will win one chance (check(s) with a total value of 50 AZN = 1 chance, check(s) with a total value of 100 AZN = 2 chances and so on). Each Participant may receive more than one check(s) to increase their chances.
- 1.8. There is no limit to the number of lottery tickets, for example, if the Participant purchases a total of 1000 manats, then he/she gets a chance to win 20 lottery tickets.
- 1.9. If the Lottery winners do not provide the information specified in clause 10 of this Terms and Conditions, the awards will remain at the Organizer's disposal.
- 1.10. Each Participant will have a unique serial number of the lottery ticket consisting of a nine-digit combination that distinguishes him/her from other participants. As many chances as each Participant will have to win in the Lottery, the same numbers of the relevant lottery tickets will participate in the Lottery, equal to those lucky numbers.
- 1.11. If the user makes the payment with another person's card instead of his own card, in case of winning, the gift will be presented to the cardholder. If the user makes the payment with an anonymous bank card, in case of winning, the gift will be presented to the card owner who presents the confirmed document that the card belongs to the user.
- 1.12. The Lottery will be held at Park Bulvar Shopping Center located at Neftchiler avenue, 42, Sebail district, Baku city, the Republic of Azerbaijan, AZ1000.
- 1.13. If it is found that the lottery participant has cheated the Organizer during the lottery in order to change the lottery results in his/her favor or to influence in any way, as well as to falsify (using computer technology or any other means), the participant loses the right to participate in the Lottery. The organizer informs the participant about this, and then will give a written warning. After conducting an internal investigation of the mentioned fact, the results of that participant and his/her chances will be canceled and he/she will be excluded once and for all period of the Lottery.
2. **Start date** of the stimulating Lottery: **25st November, 2024 at 10:00 a.m.**
3. **End date** of the stimulating Lottery: **28th March, 2025 at 22:00 p.m.**
4. Lottery ticket: consists of a 9-digit, 2-sided paper ticket.
5. Participants of the stimulating Lottery with draw: Voluntary Consumers (aged 18 years and older) that makes purchase at the sale points of PARK BULVAR via VISA card during the period of 25th November 2024 to 28th March 2025 and who are registered in accordance with clause 7 of this Terms will be considered as Participants.
6. Each citizen of the Republic of Azerbaijan shall use contactless purchases made with VISA card registered and issued in the Republic of Azerbaijan in the minimum total amount of 50 (fifty) manat, taking into account the exceptions applicable to lottery objects and lottery objects mentioned in clause 1.1 of these Terms. gives the owner 1 chance of winning.
7. In addition, if the winners will refuse to take the prizes and if it does not comply with the provisions mentioned in clauses 9 and 10 of these Terms the same prizes will remain with the Organizer. The winners of the lottery will be announced on the same day when the draw will be played on the following webpage at <https://www.instagram.com/parkbulvar/>
8. The prizes cannot be replaced with money.
9. **Acceptance of the winning lottery ticket substitutes (other paper data carriers equal to the lottery tickets) by the Lottery Organizer will commence no later than 7 (seven) working days after the end date of the draw and will last within 90 (ninety) working days. The Organizer should present to the winners the prizes within 10 (ten) working days after the acceptance of their requests.**
10. The winners must present (i) identification card (ii) bank card (or proof of ownership in the case of lost and untitled bank cards), winning lottery ticket and cashier's check belonging to the lottery ticket to claim their Prizes together, they should apply to the Organizer of the stimulating lottery at 42 Neftchilar Avenue, Sebail District, Baku City, Republic of Azerbaijan, AZ1000.
11. The Winners shall not transfer their Prizes to any third party. Excluding VAT payment, all other taxes and legal obligations relating to the prize are the responsibility of the winners.
12. The winner of the stimulating Lottery with draw should not be younger than 18 and shall be the citizen of the Republic of Azerbaijan and he/she and accompanying person should have right in accordance with the legislation of the Republic of Azerbaijan. For the avoidance of doubt, only citizens of the Republic of Azerbaijan can participate in this lottery, foreigners and stateless persons living in the Republic of Azerbaijan cannot participate in this lottery. Persons not having the required documents for receiving the Prizes or having problems with documents are responsible for getting those documents. They cannot demand getting those documents or their expenses from the Organizer.
